
Dr. Ahmed was recently entrusted by the Government of Bangladesh and International Maritime Organization (IMO) to draft both the Ship Recycling Rules and the Ship Recycling Act, aligning national legislation with the provisions of the Hong Kong Convention (HKC), officially the Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships ahead of its global entry into force on 26 June 2025.


